2014 Legislative Session Begins

The 2014 Legislative Session convened on Monday, January 13th. Legislators will be able to consider bills that did not pass last year as well as introduce new bills and consider new ideas this year. 2014 is an election year for all members of the Kansas House of Representatives and all statewide elected officials, including the Governor, Attorney General, Secretary of State, Treasurer and Insurance Commissioner. Because it is an election year, and because issues like school finance will loom large this year, the 2014 session likely will be an interesting one.

Join the Medicaid Expansion movement

By expanding Medicaid, low-income Kansans will have access to health coverage, and there is potential to undo the profound health disparities in our state. As it currently stands, uninsured Kansans are far likelier to develop serious health complications or die younger from disease that are too often preventable. By gaining health insurance through Medicaid, we would add health coverage for as many as 100,000 Kansans within five years who otherwise would remain uninsured.

Join advocates in telling Kansas lawmakers about the importance of Medicaid expansion in Kansas by signing the petition today.

financial capacity to pay for dental services, improving public oral health, and increasing awareness among policymakers of the importance of oral health. Following are the priorities for this year. Watch for them on our website soon as well.

- Support Registered Dental Practitioner legislation.
- Support recruitment and retention efforts to increase dental providers in underserved areas.
- Support policies to enhance the Extended Care Permit law.
- Support efforts to make better use of the current school dental screening law to promote dental care among children.
- Advocate expanding access to KanCare.
- Promote fair implementation of the children's dental benefit in the Affordable Care Act.
- Advocate with the KanCare managed care organizations for inclusion of a comprehensive dental benefit for all Kansas Medicaid beneficiaries.
- Provide general oral health information to individual legislators and committees as appropriate.
- Convene the Oral Health Caucus to arm legislative supporters with information about oral health policy and generate more awareness of the issue among legislators.
- Preserve existing community water fluoridation in Kansas.
- Support the existing statewide indoor smoking ban and efforts to reduce access to tobacco products.
- Advocate including oral health questions in the eligibility determination tools in the aging, disabilities, and early childhood service systems, so that care plans account for oral health.
