The legislative session is in full swing and oral health is on the docket, just not the way we would like.

[HB 2372](#) is

scheduled for a hearing in the House Health and Human Services Committee on February 5th at 1:30 pm. The bill requires cities and other entities that fluoridate drinking water to notify consumers "that the latest science confirms that ingested fluoride lowers the I.Q. in children." Though blatantly false, if passed, the bill could have a detrimental effect on community water fluoridation statewide. We need your help to kill the bill!
