## Bridge to a Healthy Kansas: a Medicaid expansion plan

A proposal written by the Kansas Hospital Association (KHA), introduced a medicaid expansion bill called a [Bridge to Healthy Kansas](#), was introduced in the House committee this week. The plan is similar to [Indiana's medicaid expansion plan](#). The Bridge to a Healthy Kansas plan is budget neutral, hence it does not need State General Funds. It will not be an additional cost to Kansas taxpayers and will likely be a net gain for Kansas. The plan is not free care for consumers and it does hold them accountable. Below is an outline of the plan:

### Eligibility requirements -

- The program covers participants who: Are legal residents or U.S. citizens and full-time residents of the state of Kansas

Work 20+ hours per week; those who do not work at least 20 hours a week must be involved in work training, or they must be a student or a stay-at-home parent to be eligible

- Demonstrate personal responsibility by paying a portion of the cost of their health care
- Preventive care - the program covers qualifying preventive care at no expense to participants
- Federal funding - the program is funded in part by federal funds as set forth in the Affordable Care Act (ACA), and the program will automatically terminate if federal funding is reduced below the requirements set forth in the ACA

This week the U.S. Department of Health and Human Services' Office of Inspector General released a report about dental services for children who are enrolled in Medicaid programs. The majority of low-income children in the United States have Medicaid coverage for dental care, and this report showed that 75% of children enrolled in Medicaid in four states are not receiving all the required childhood dental services. The report's authors noted, "Access to dental care for children with Medicaid has been a longstanding concern. When children lack dental care, untreated decay and infection in their mouths can result in preventable emergency room visits or more complicated and expensive dental and medical interventions later in life."

Medicaid programs (known as KanCare in Kansas) include a mandatory program for children called Early and Periodic Screening, Diagnostic, and Treatment (EPSDT). Through EPSDT, state Medicaid programs are required to cover all medical-necessary dental services on a schedule that is specified in each state's policies. The report showed that children enrolled in Medicaid in California, Indiana, Louisiana, and Maryland did not receive all the required services. The authors cited several challenges in providing all the services on the appropriate schedule, including shortages of Medicaid dental providers and challenges in teaching families about the importance of routine dental care for their children.

The OIG made eight recommendations states can implement to improve the number of Medicaid-enrolled children who are receiving the required dental services. One recommendation is that states should analyze the effects of Medicaid payments on access to dental

providers. Medicaid payment rates typically are far lower than those of private insurance plans. In Kansas, the Medicaid rates are generally less than half as much as private insurance rates. Another recommendation was that states improve education for families about the importance of dental care. Kansas has focused on this strategy for many years, and the Kansas Head Start Association and Oral Health Kansas have been at the forefront of creating educational materials and programs for underserved populations, including children. While Kansas was not a part of this OIG study, our state is working on increasing the number of children enrolled in Medicaid who receive dental services. Kansas is one of five states participating in an Oral Health Initiative sponsored by the federal Centers for Medicare and Medicaid Services. Through the Oral Health Initiative, the Bureau of Oral Health, Medicaid program, KanCare managed care organizations, and advocacy groups like Oral Health Kansas are partnering on ways to increase the number of children who receive a preventive dental service each year, as well as the number of children who receive dental sealants.
