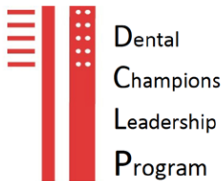
Registered Dental Practitioner (RDP) Advocacy Day

Pass on Pop with the KAC

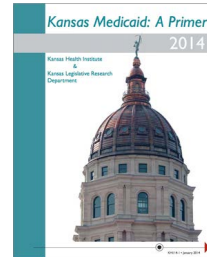

Medicaid Primer Released

The Kansas Health Institute (KHI) and the Kansas Legislative Research Department have released the 2014 Medicaid Primer. According to the KHI, Medicaid and the Children's Health Insurance Program (CHIP) play a substantial role in the Kansas health care system by providing health and long-term care coverage to the state's most vulnerable populations. In 2013, the state significantly changed the way Medicaid and CHIP services are administered and delivered in Kansas through a new initiative called KanCare. In addition, federal health policy changes in the Affordable Care Act (ACA) affect Kansas Medicaid and CHIP. As part of the ACA changes, legislators and state officials must decide whether to expand the Kansas Medicaid program to include more adults. 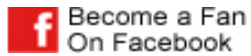
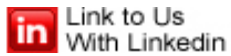
