Update from Under the Dome

Today Kansas bids farewell to Governor Sam Brownback. After seven years in office, he is leaving today to become the U.S. Ambassador of Religious Freedom.

[Brownback is the fifth Kansas Governor to leave office early.](#) He followed

Kathleen Sebelius who also left in her seventh year in order to become U.S. Secretary of Health and Human Services. Lt. Governor Jeff Colyer took the oath of office at 3 pm today and will serve out the remainder of Brownback's term. He is running for election to that office this November, and either Dr. Colyer or one of at least 20 other gubernatorial candidates will become the next Governor of Kansas in January 2019.

KanCare 2.0

Dr. Colyer has been a key player in the administration's efforts to create and launch KanCare, the state's Medicaid managed care program. KanCare is in a transition period of its own, as it expires

in December 2018, and managed care companies have entered bids to provide services under KanCare 2.0, which would begin in January 2019. Last Wednesday, Governor Brownback announced the state would halt the process to usher in KanCare 2.0, which involves not only awarding new contracts to managed care organizations, but also receiving federal approval to continue the program. Legislative leaders have expressed concern about transitioning to KanCare 2.0 and introduced [SB 300](#) to require the administration to secure legislative approval before making significant changes to KanCare, among other things. SB 300 received a hearing on January 30, but action on the bill has not been scheduled.

Dental therapy bills

Last week the Senate Public Health and Welfare Committee introduced two bills to establish a dental therapist model. [SB 308](#) is similar to bills introduced in recent years, and [SB 312](#) is being called a compromise bill. It includes a slightly different set of procedures that can be provided by a dental therapist and changes the supervision level for several of them from general to direct. SB 312 will receive a hearing on February 1, and Oral Health Kansas will testify in support, as we have on previous dental therapy bills.

When Public Health and Welfare Committee Chair Senator Vicki Schmidt introduced SB 312 she described the bill as the result of many years spent gathering information and input from interested organizations in an effort to advance access to oral health care. She
