## HB 2372 Killed in Committee



On February 24, the House Health and Human Services Committee overwhelmingly voted to table HB 2372. This vote effectively kills this anti-water fluoridation bill for the year in the House. The bill would have required local water departments that fluoridate their water to notify customers that water fluoridation lowers IQs in children.

Oral Health Kansas and many partners worked together to defeat this bill over the last several weeks. Countless calls, emails and visits were made to legislators telling them about the benefits of water fluoridation. Twenty-six organizations provided testimony or statements in opposition to the bill, including a wide range of statewide organizations, public organizations, national advocates and individuals. Thanks in particular go to the five people who testified before the committee:

HB 2372 was introduced in 2013 and originally was scheduled for a hearing in mid-January 2014. That hearing was postponed to early February when it was rescheduled again due to the large winter storm that dumped over 13 inches of snow in Topeka. The outpouring of support for water fluoridation and against the bill continued throughout January and February and is a significant reason the bill was defeated.

## ECP III Training Course Offered at UMKC

UMKC School of Dentistry is advertising their training course for Registered dental hygienists interested in applying to the Kansas Dental Board for ECP III certification. This course is offered as an on-line course and will conclude with a practical lab component and competency exam held on-site at the dental school. The course will cover the content specified for the ECP III certification. Upon completion of the course, the student must apply separately to the Kansas Dental Board for the ECP III certification. I or II certification is not required to be eligible for this course however; hygienists with limited public health background may be interested in the "Safety Net" course which UMKC also offers online for hygienists interested in ECP I and II certification.

Registration is now open for the course and will remain open until March 14, 2014. The course will be at capacity when 20 participants are registered. The online portion of the course will be opened for participants on February 17, 2014 and a practical lab component and competency exam will be held at UMKC School of Dentistry in May 31, 2014.

## Medicaid Expansion Advocacy




