### Data shows sugar consumption in the US

According to [data](#) from 2011-2014 National Health Nutrition and Examination Surveys (NHANES), half of adults and two-thirds of kids drink at least one sugar-sweetened beverage per day, according to the report findings. On average, 7% daily calories comes from sugar-sweetened beverages. Among U.S. youth aged 2-19 years, 64.5% of boys and 61.3% of girls consumed at least one sugar-sweetened beverage on a given day during 2011-2014.

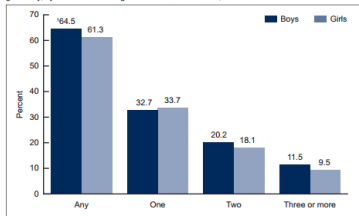
## Committee allows three days for KanCare expansion hearings

This week, House Committee on Health and Human Services listened to testimony from opponents, neutral and proponents to [House Bill 2064](#). This bill, also known as the KanCare Bridge to a Healthy Kansas program, will promote and administer the program to potentially eligible individuals who are medically underserved in Kansas. Oral Health Kansas provided [written testimony](#) in support of HB 2064. When eligibility for KanCare is expanded, at least 150,000 low-income adults will have access to the preventive dental services offered by the KanCare contractors.

The [Kansas Health Institute reported](#) the latest-available data from the U.S. Census Bureau's American Community Survey (2015) and the Centers for Medicare and Medicaid Services about 41,000 children and 222,000 adults are uninsured in Kansas, though many are already eligible for Medicaid or subsidies to purchase health insurance on the marketplace.

Today, hundreds of advocates gathered at the Capitol to share their support before the 1:30pm proponents hearing. The [Alliance for a Healthy Kansas](#) reported about 160 organizations and individuals submitted testimony.

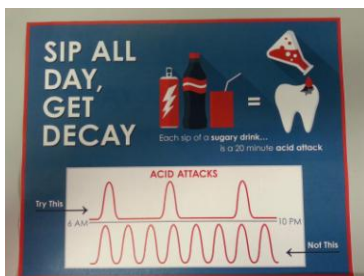


\*Significantly different from girls,  $p < 0.05$ .
