## February is Children's Dental Health Month

February is National Children's Dental Health Month to raise awareness about the importance of oral health. This message is essential to the health and well being of all children, starting at birth and continuing on through high school. When children's oral health suffers, so does their ability to learn.

Very young children need to develop daily dental hygiene and "teeth healthy" eating habits. This is the responsibility of families, child care providers, early childhood educators, school nurses, and special education professionals. Children's physicians and nurses also have a role to play by making sure children at risk for dental decay are receiving fluoride varnish treatments and by screening the child for signs of tooth decay.

Children need to see a dental professional by age one to make sure that the child's first teeth are coming in correctly and to educate families about how to keep their children cavity-free for life.

Students need to learn about the science behind oral disease and how to have a healthy mouth for a lifetime. They benefit from learning about the science underlying tooth development as well as the harm to their mouths that comes from smoking, chewing tobacco, mouth piercings, illegal drug use and playing sports without a mouth guard. Oral disease is unsightly, costly, and at times life-threatening. Too many Kansas children end up in surgery as a result of dental decay, at a cost that can top \$20,000.00. If tooth decay and gum disease are

## Medicaid Expansion Estimate Released

On February 8, Governor Brownback's administration released their actuarial study of the potential cost of Medicaid Expansion in Kansas. The June 2012 U.S. Supreme Court decision made the Medicaid eligibility expansion optional for states. Medicaid expansion would allow all people whose income is lower than 138% of the Federal Poverty Level to receive Medicaid coverage. According to the Congressional Budget Office, covering the lowest income Americans on Medicaid will be more cost effective than covering them with subsidies through the Affordable Care Act's Insurance Exchange.

The state's estimate is that \$1.1 billion in state funds would be spent on expansion. According to news coverage of the Governor's estimate by the [Kansas Health Institute](#), "Currently, Kansas has among the nation's most restrictive eligibility standards, limiting Medicaid coverage to poor children, pregnant women, the disabled and elderly. Childless adults are excluded regardless how little income they have." More details on how the state's projections were made will be released this week.

Several studies have been released in recent weeks estimating the cost of expansion for Kansans. The Kansas Health Institute published an [issue brief](#) on Medicaid Expansion in December that details many of the variables.

Oral Health Kansas is supportive of expanding the Kansas Medicaid program in 2014 as envisioned in the Affordable Care Act. Through Medicaid Expansion, over 120,000 very low-income Kansas adults would be able to receive Medicaid services, including the new preventive dental benefit, with a greatly enhanced federal matching rate. The opportunities to cost effectively meet the dental and medical needs of adults in poverty are available through Medicaid Expansion.

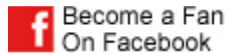
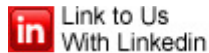
