Senate prepares to take on Medicaid expansion

Last week, the Kansas House passed a Medicaid expansion bill by a vote of 81-44. The passage of HB 2044 marked the most significant progress for Medicaid expansion in our state. Over 150 individuals and organizations submitted testimony in favor of the bill when the House Health and Human Services Committee held hearings earlier in February.

Now, the Senate is poised to take up the issue. The Public Health and Welfare Committee has scheduled two days of hearings on HB 2044 in March. The proponents will testify on March 20, and the opponents will testify on March 21. Oral Health Kansas provided testimony in
