Scores gather to push Medicaid Expansion

The House Health and Human Services Committee saw a record large crowd assemble today for the first of two days of hearings on Medicaid Expansion in Kansas. Over 170 people and organizations, including Oral Health Kansas, **submitted testimony** in favor of expanding the state's Medicaid program known as KanCare.

The Affordable Care Act allows states to expand their Medicaid programs to cover adults with incomes of up to 138 percent of the federal poverty level. Currently, low-income adults without children do not qualify for KanCare at all. Only adults with disabilities, who are elderly, or who are pregnant qualify for Medicaid. As many as 151,000 Kansans would be able to access health and dental care through KanCare if Kansas expands Medicaid. These adults, by and large, are the working poor - they work in food service, as CNAs, or in janitorial positions. They probably make minimum wage or a bit more, and that is not enough to pay for private health insurance in addition to basic living expenses.

If the Governor and the Legislature approve Medicaid Expansion, nearly half of the state's uninsured adults will be covered by KanCare. They also will have access to the KanCare preventive dental benefit, which is helping more Kansans than ever address their oral

CMS Announces Special Enrollment Period for Tax Season

The Centers for Medicare & Medicaid Services (CMS) announced a special enrollment period (SEP) for individuals and families who did not have health coverage in 2014 and are subject to the fee or "shared responsibility payment" when they file their 2014 taxes in states which use the Federally-facilitated Marketplaces (FFM). This special enrollment period will allow those individuals and families who were unaware or didn't understand the implications of this new requirement to enroll in 2015 health insurance coverage through the FFM. This period of enrollment began March 15 and goes through April 30, 2015.

Kansans who want to find a Navigator or other assister in their area, can visit www.insureks.org. These Cover Kansas Navigators have completed training with CMS, passed background checks and are available at trusted community organizations around our state.
