## Navigator Bill Heard in House Health Committee

The House Health and Human Services Committee heard [SB 362](#), also known as the Navigator bill, on Wednesday. The bill claims to institute consumer protections, but conferees noted that SB 362 does not create any new protections than those already in place. Current practice in Kansas, which is consistent with federal law, requires Navigators to undergo criminal background checks, screenings for conflicts of interest, complete 20-30 hours of training, and receive an annual certification from the Centers for Medicare and Medicaid Services. Kansas has 168 Navigators, none of whom get paid for this work. Almost all of them work for health care providers or social service agencies and help people sign up for health insurance through the marketplace as a function of their job or on evenings and weekends.

Concerned about a chilling effect, members of the committee called into question one element of SB 362, which requires the Attorney General's office to investigate complaints against Navigators, and requires Navigators to pay for the investigations, even if they are acquitted of the charges. Opponents also raised the point that Navigator-like assistants have been helping consumers untangle the process of insurance coverage within Medicare Part D and KanCare, without complaint or concern about fraudulent use of personal information.



Dr. Cindy Sherwood, D.D.S. from Independence, KS testified on HB 2611 before the Senate Public Health and Welfare Committee on March 12. She said changing the 50 percent rule to a 20 percent rule is a "win-win-win for patients, dentist owners and new dentists."

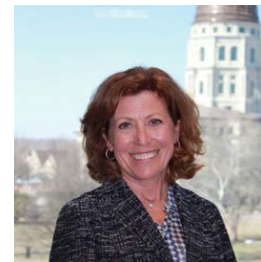
## AEGD Director Job Opening at

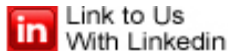
