Tobacco Tax

Last Thursday, March 15th, the House Taxation Committee held a hearing on HB 2231. [HB 2231](#) would increase the cigarette tax by \$1.50, raise the other tobacco product tax from 10% of the wholesale price to 65%, and develop a tobacco prevention and cessation fund. The last time the tax rate on these products was addressed in Kansas was in 1972 when the tax was originated. This tax increase is long-overdue. An identical bill to HB 2231, [SB 376](#), will have a hearing in Senate Assessment and Taxation tomorrow morning at 9:30AM.

What can you do to help?

Water Access Manager, Kelly Rippel toured all ten participating school buildings within Haysville USD 261, and delivered a drink display of their own and Sippy FatHead™ wall decals for each location. During the walk-through with district nurses, all water access points were evaluated.

KDHE Screens Children For 2018 Smiles Across Kansas

Last week, the [Kansas Bureau of Health Promotion](#) took another important step on their way to launching the 2018 Smiles Across Kansas survey. This basic screening survey, last done in 2012, is a statewide, nationally recognized oral health surveillance of children's oral health. The team of 3 hygienists offered dental screenings for children at the Adams street Boys and Girls club in Topeka. This event provided an opportunity for the screeners to calibrate their findings to ensure the integrity of the data they will be collecting on 3rd graders from select schools across the state.


