Affordable Care Act Anniversary

Today is the one year anniversary of the Affordable Care Act. The ACA marks the first time in history that all children in America will be guaranteed access to dental insurance, either through state Exchanges or Medicaid/Children's Health Insurance Program. While legal challenges to parts of the law remain active across the country, the law remains intact today.

Earlier this month OHK reported that Kansas Insurance Commissioner Sandy Praeger has launched a series of eight work groups to help design the state Exchange for Kansas. Oral Health Kansas staff serves on the Steering Committee and work groups that are helping to design the business operations of the Exchange and the role of Navigators. Questions being tackled by the work groups involve how many Exchanges Kansas should have, what functions the Exchange should engage in, and what types of plans should be offered.

The Steering Committee plans to meet throughout the spring and summer to consider recommendations from each work group. There are tentative plans for public input meetings in September and October. The goal is to have a plan for a State Exchange ready to take to the Kansas Legislature in 2012. The U.S.

Oral Health Kansas is excited to announce our participation in The Champions Project - a mini-grant contest presented by Delta Dental of Kansas and the Delta Dental of Kansas Foundation. We have been 'championed' by a team of DDKS employees who are promoting our cause, but we need your help too! Clean Air Act Intact

This morning the Kansas House of Representatives approved a bill that would strengthen the Clean Indoor Air Act (passed a year ago) by outlawing smoking in state-owned casinos. The bill passed on a strong vote of 97 to 26.

Clean Indoor Air advocates, including Oral Health Kansas, have worked hard over the past few days and weeks to ensure the law would not be weakened this year. While a January 2011 poll indicated significant support among Kansas voters, including smokers, for the Clean Indoor Air Act, there was a lot of interest on the part of some legislators to repeal it this year.

KDHE Bureau of Oral Health Loan Repayment Program

The KDHE Bureau of Oral Health announces that applications are currently being accepted for their loan repayment program designed to provide loan repayment assistance for clinicians practicing in underserved areas or to underserved populations who would not qualify for other types of assistance (i.e., National Health Service Corps or State Loan Repayment). Clinicians receive assistance on a prorated scale starting at a minimum of 16 hours per week working at an eligible site. Dentists and dental hygienists are eligible. A one year commitment is required and funding is not guaranteed beyond one year.

Funding is limited and applications will be accepted through April 15, 2011.

2011 Legislative Session Update

This Legislative Session has been very busy. From advocating for a dental benefit for all Kansas Medicaid beneficiaries, to getting children who are eligible to be seen by ECP hygienists in schools actually seen by the ECP hygienists, as well as expanding and strengthening the dental workforce in Kansas, and many more. 11th Kansas Non-Traditional Occupations Statewide Scholarship Competition


