### SB 233 Could reduce in oral cancer in Kansas

On March 24, the Senate Assessment and Taxation Committee heard testimony about Governor Brownback's proposal to increase the tobacco and liquor taxes. The tax proposal is part of the Governor's approach to filling the \$700 million budget gap in the next year, but it also would have a profound impact on the health of Kansans.

The bill would increase the state's cigarette tax by \$1.50 per pack, as well as increase the tax on other tobacco products (which includes smokeless tobacco) from 10 percent of the wholesale price to 25 percent. The "other tobacco products," also known as "OTP" tax has not been increased since 1972. Increases in tobacco taxes reliably produce two results: an increase in state revenue and a decrease in tobacco users.

Oral Health Kansas joined other health advocates in testifying in favor of the bill. According to the Oral Cancer Foundation, every hour of every day, one person dies of oral or pharyngeal cancer. Smokeless tobacco is a notorious and deadly carcinogen. Only half of people diagnosed with oral cancer survive. Kansas' OTP tax rate is among the lowest in the nation, and Oral Health Kansas urged the committee to increase it now.

## Special Enrollment Period for Tax Season Open

The special enrollment period will allow those individuals and families who were unaware or didn't understand the implications of this new requirement, the shared responsibility payment, to enroll in 2015 health insurance coverage through the Federally-facilitated Marketplaces (FFM). **This period of enrollment began March 15 and goes through April 30, 2015.**

## Children's Dental Health Grant Opportunity

The [ADA Foundation](#) is accepting applications for the Samuel D. Harris Fund for Children's Dental Health. The grant program is named for noted pediatric dentist and philanthropist Dr. Samuel D. Harris who passed away in 2003 and is designed to bestow grants on organizations dedicated to fighting children's dental disease for prenatal and postnatal oral health

liquor industry lobbied against the bill. Cigar lobbyists, in particular noted that cigars are not addictive, but they would be subject to the OTP tax. Oral Health Kansas argued that cigars may not be addictive, but smokeless tobacco is both highly addictive and deadly.

The Senate committee is not likely to take action on this bill until later in the session. Advocates are encouraged to contact both Senators and Representatives and ask them to save lives by increasing the cigarette and OTP tax rates this year.

## Medicaid Expansion is still on the table

Last week, the House Health and Human Services Committee held two days of hearings on Medicaid expansion. By expanding the Kansas Medicaid program known as KanCare, as many as 150,000 low-income Kansans would gain access to Medicaid coverage of health and dental care. The Legislature has not taken action on a Medicaid expansion proposal yet, but the issue is on the table for consideration during the 2015 Legislative Session.

Twenty-eight states have expanded their Medicaid so far, and Kansas remains one of the twenty-two states that has not. Several
