Dental Champions Corner

March 31 Deadline to Enroll in Health Insurance Plans

The deadline to enroll in a health insurance plan through the federally-facilitated marketplace is March 31! After the deadline, consumers are not allowed to enroll in a plan until the next open enrollment period without a qualifying life event, such as a birth or job change. To enroll, visit: insureks.org.

Legislative Action

At last update, SB 362, also known as the Navigator bill, had a hearing before the House Health and Human Services Committee. Though proponents touted the bill as consumer protections, the new regulations it would have



placed on the volunteers who help consumers navigate the process of signing up for health insurance through the marketplace would have been crippling. The committee voted unanimously to table the bill. Further action is not expected; the bill will die automatically at the end of session.

HB 2611 secured final passage in the Senate, 40-0. With this final step in the legislative action complete, dentist-owners are now required to spend 20 percent of their time in satellite practices--down from 50 percent of their time. The Kansas Dental Association and private
