## Medicaid Expansion is a Sound Investment

This week Oral Health Kansas sent a [letter](#) to Governor Brownback urging him to expand the Medicaid program to cover an additional 100,000 low-income Kansas adults in 2014. The ACA offers states an unprecedented opportunity to provide health insurance for very low-income adults. Governor Brownback is considering the option to expand eligibility in Kansas.

This year preventive dental benefits became available to all adults on Medicaid, therefore Medicaid expansion would ensure tens of thousands more Kansans would have access to preventive dental services.

As reported in recent "Weekly Wednesday Updates," the Kansas Hospital Association estimates \$3 billion new dollars would enter the state's economy and 4,000 jobs would be created as a result of Medicaid expansion. Medicaid expansion offers the chance to make this significant investment in the state's economy. Oral Health Kansas sees the opportunity to reduce the number of uninsured Kansans as well as the chance to give the state's economy a major boost as a sound investment in the future of our state.

At a press conference on Monday, KHCC Executive Director Anna Lambertson said expanding Medicaid eligibility in Kansas will have a bigger impact than in other states, because our state's Medicaid eligibility requirements are among the lowest in the country. She pointed out the benefits of expansion lie beyond just providing health insurance to low-income adults, "When Kansans are able to access the health care they need, they live healthier, more productive lives."
