National Child Abuse Prevention Month

April is National Child Abuse Prevention Month, a time to raise awareness about child abuse and neglect and create strong communities to support children and families. Child abuse is any mistreatment or neglect of a child that results in harm or injury. Neglect can be just as harmful as abuse. Neglect is defined as the failure of a parent or guardian or other caregiver to provide for a child's basic needs. Warning signs of oral health neglect could include the following:

1. Child displays poor oral hygiene
2. Extensive amount of cavities in the child's mouth
3. Untreated pain or infection in the mouth
4. History or lack of follow through of care

The National Oral Health Conference took place in Pittsburgh, PA, last week. Kansas was well-represented at the conference, with several people from across the oral health network in our state taking part in the activities.

Oral Health Kansas staff co-presented on tips for a successful state oral health coalition. Over fifty people participated in the presentation. Many asked insightful questions about state coalition make-up, sustainability, and advocacy evaluation. A copy of the presentation is available on our website. Staff also helped host a first meeting of state oral health coalition leaders from across the country. The group began to identify ways in which coalitions can collaborate and share resources/best practices.

Staff participated in the ASTDD's School and Adolescent Oral Health Committee and ASTDD's Early Childhood Oral Health Committee. Finally, OHK staff spent time building relationships with researchers on initiatives to improve oral health for elders and people with disabilities.

The 2012 National Oral Health Conference will be held April 30 - May 2 in Milwaukee, Wisconsin.


