US House may vote to repeal ACA tomorrow ... Take action today

A proposed amendment authored by U.S. Rep. Tom MacArthur (R-NJ), in consultation with U.S. Rep. Mark Meadows (R-NC), has revitalized the effort to repeal and replace the Affordable Care Act (ACA). We may see it come up for a vote as early as tomorrow, Thursday, May 4th.

- The proposed amendment would allow states to apply for waivers from ACA regulations such as essential health benefits that protect children's oral health.
- The proposed amendment would also allow a state to apply for a waiver allowing insurers to charge more for individuals with pre-existing conditions based on the condition the state must have a high-risk pool.

Status

House Republicans are still reviewing the proposed amendment and it is unclear


