Report Issued on ACA Dental Coverage



On April 30, the National Academy for State Health Policy (NASHP) released a new report on dental benefits in the Affordable Care Act. The report, "Improving Integration of Dental Health Benefits in Health Insurance Marketplaces," addresses the shortcomings associated with the roll-out of the pediatric dental benefit in the Affordable Care Act (ACA).

The report was released at the National Oral Health Conference in Ft. Worth, Texas, during a panel discussion about the ACA dental benefits. It details the affordability challenges in the implementation of the pediatric dental benefit, which is designed to be one of the ten Essential Health Benefits to be offered to everyone who purchases health insurance. For example, stand-alone dental policies are not included in the calculation of the premium tax credits, which is the mechanism designed to help people under 400% of the Federal Poverty Level be able to afford to purchase insurance. Another challenge is that dental benefits are subject to an out-of-pocket maximum that is separate from the maximum amount families can pay for health care. The result is that people who purchase pediatric dental coverage may be subject to a higher overall cost

for health and dental insurance than was originally designed in the Affordable Care Act.

Adult dental benefits were not included in the Affordable Care Act's list of ten Essential Health Benefits. The report describes the fact that dental policies are available both inside and outside the ACA's marketplaces, but that the adult dental coverage is not eligible for premium tax credits. NASHP notes in their report, "This (adult dental coverage offered in some plans) is a potentially promising way to reduce high levels of dental uninsurance among adults."

NASHP convened stakeholders in January 2014 to identify potential policy solutions that could improve how dental benefits are provided in future years. A compilation of suggestions made by the panel are included in the report. They relate to benefit design, affordability and consumer experience. The report's authors point out, "While implementation of dental benefits is only a small part of the work that state and federal officials must do to implement ACA, maintaining good oral health is important to every person's ability to eat, learn, work and interact with others, so it is important that this coverage work as intended."
