## School Vending Machine Policy



On May 12, the Kansas State Board of Education adopted a policy that required all accredited K-12 schools in Kansas to implement the Advanced level of the Kansas School Wellness Policy Model Guidelines for foods and beverages sold in vending machines by August 1, 2010, and to implement the Exemplary level of the guidelines by August 1, 2011.

During the State Board's June meeting, some Board members attempted and failed to overturn that policy.

The State Board met this week and received feedback from stakeholders regarding the policy. Several, including Oral Health Kansas, thanked the Board for their leadership on creating a healthy learning environment for Kansas schoolchildren. Others asked the Board to re-consider or delay implementation of the policy. The primary arguments against the policy centered on potential revenue loss to schools, which assumes that schools will see lower vending machine sales, and on a desire for the beverage industry to be able to sell diet sodas in the school vending machines.

One school superintendent thanked the Board of Education for creating consistency for the children in his district. He said now all children in his district will see only healthy food and beverage options at breakfast, lunch and in the vending machines.

While no action was taken to attempt again to overturn or delay

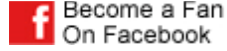
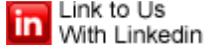
