**Medicaid Reform Forum Wrap Up on August 17**

Earlier this summer the Lt. Governor held three Medicaid Reform Forums in Topeka, Wichita and Dodge City. Oral Health advocates took part in each of the forums. During those forums, the Lt. Governor made an important point: "We're dealing with people with multiple medical problems." This is an excellent point and provides the opportunity to share the message that the mouth is connected to the body, and dental care needs to be provided to ensure the whole person stays healthy.

Participants in the forums were asked to make suggestions about improving the Medicaid program for the major population groups served: elderly people, people with disabilities, and children/families/pregnant women.

This week, KDHE Secretary Moser is hosting a series of work group-style webinars to ask advocates more in-depth questions about each of the three Medicaid population groups. There is no mention yet of dental benefits as a key in providing preventive care and in ensuring people are able to maintain their overall health.

Next Wednesday, the Lt. Governor will host a final wrap-up forum at the Overland Park Convention Center. It is one more opportunity to explain the importance of a dental benefit for all Medicaid beneficiaries. Details about the meeting, including the link to RSVP are below:

## **Kansas Returns Early Innovator Grant**

In February the Kansas Insurance Commissioner's office was awarded an Early Innovator Grant from the U.S. Department of Health and Human Services to jumpstart the state's efforts to develop a State Health Exchange. Kansas was among just six other states to be awarded such a grant. As a part of the Health Exchange, a web-based portal will be developed that Kansans can use to explore their health insurance options and select a plan. Much of the funding in the grant was to be used for technology infrastructure coordination and consultation. Yesterday Governor Brownback announced that Kansas will return the \$31.5 million grant to the federal government.

In his announcement, the Governor said, "There is much uncertainty surrounding the ability of the federal government to meet its already budgeted future spending obligations. Every state should be preparing for fewer federal resources, not more. To deal with that reality Kansas needs to maintain maximum flexibility. That requires freeing Kansas from the strings attached to the Early Innovator Grant."

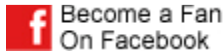
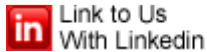

OHK staff continues to serve on a variety of Exchange planning work groups, as well as the Steering Committee. The next Steering Committee meeting is scheduled for later this month.
