OHK staff educates children at summer program on healthy habits

We were delighted when Parents as Teachers USD 501 asked us to come do an educational session with the Deer Creek Community Center summer drop in program children. Marcia and Doug excitedly spoke to a group of 30 school-aged (5-14) children about healthy eating and drinking habits. Children were then to walk through each activity center: one on sugary beverages, one on good choices in food, one to draw a poster on the topic of dental health, and a tooth brushing center. The children were surprised to learn how much sugar was in beverages AND foods. They practiced counting each teaspoon of sugar in a drink and how to read labels. They learned which foods are every day foods and which ones are special foods, for special occasions, such as cake and candy as well as the importance of drinking fluoridated water. The children were also shown how to properly brush

Medicaid rate cuts hamper dental services

One of the state budget balancing strategies this year was to cut KanCare (Kansas' Medicaid program) rates by four percent. The cut, which went into effect last month, is hampering an already-stressed Medicaid dental provider network in Kansas, and Kansas dentists are speaking out about it. Dr. John Fasbinder is an oral surgeon in Prairie Village who is a KanCare dental service provider. In the stories published this week, Fasbinder talked about how difficult it is for dentists to be KanCare providers because the rates are about 40% of the private insurance rates. He said, "To take money away from a system that's already compensating so little is not the answer." Thousands of Kansans who are covered by KanCare already have difficulty finding a dentist that accepts Medicaid, and that situation will be exacerbated by the new rate cut.

Dr. John Fales, an Oral Health Kansas Board member and Medicaid dental provider, shared a similar sentiment when he provided testimony to the Centers for Medicare and Medicaid Services (CMS) earlier this month. He said, "A 4 percent decrease in reimbursement will likely be the death knell for KanCare's ability to provide local access to dental care for these patients without an adequate number of dental providers."

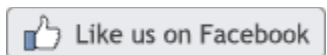

Kansas Oral Health Connections begins a new grant year

The organizations that are members of the group known as "Kansas Oral Health Connections" kicked off a new grant year this month when the DentaQuest Foundation approved another year of funding for this collective impact project. Together, six organizations, along with countless other partners will work on a series of projects and interventions to improve oral health for young children, school-age children, and adults. The group also will conduct research to collect oral health data and develop tools to improve public awareness about the value of oral health to overall health.

Among the project the partners will take on over the next year are establishing a work group to address perinatal, infant and toddler oral health; preparing to launch a third grade Basic School Survey, publishing an updated County Oral Health Snapshot; advocating for adult dental services in KanCare; and develop educational curricula for child care providers and Navigators.
