Achieving a health impact in 5 years includes community water fluoridation


The Centers for Disease Control and Prevention (CDC) has announced the release of [HI-5, "a list of non-clinical, community-wide approaches with a proven track record"](#). Each intervention listed is associated with improved health within five years and is reported to be cost-effective or cost-saving over the lifetime of the population or even earlier. Public and private organizations can use this list to quickly assess the scientific evidence for short-term health outcomes and overall cost impacts of community-wide approaches. The Health Impact in 5 Years (HI-5) initiative highlights non-clinical, community-wide approaches that have evidence reporting 1) positive

Water fluoridation is one of the HI-5. Fluoride prevents tooth decay by keeping tooth enamel strong, providing a protective barrier against harmful bacteria. Dental caries is the most chronic disease in children and adolescents. [According to the CDC](#), among adults aged 20-64, 91 percent had dental caries and 27 percent had untreated tooth decay. Community water fluoridation has been a major contributor to the dramatic decline of tooth decay in the U.S. in the 1900s. CDC declared community water fluoridation one of the ten greatest public health advances of the twentieth century. Studies have shown caries are substantially lower in the communities with fluoride.



Dental providers call for Medicaid Dental Advocacy

Last week several Kansas dental providers called for more advocacy to improve the dental services offered through the KanCare program (Medicaid) in a conference call with KanCare managed care organizations. The call was chaired by Prairie Village dentist, John Fasbinder. The main topic of conversation was the 4% Medicaid rate cut enacted last month as a part of a package of cuts to balance the state budget.

Concern was expressed during the call about the adequacy of the KanCare dental provider network. According to state officials, 395 dentists are enrolled as KanCare providers. Oral Health Kansas staff participated in the call and encouraged people to talk to legislative candidates this fall about the importance

of Medicaid dental services. Read more about the conference call from the [KHI News Service](#).

State officials announced this week that public forums would not be held about the 4% rate cut. They offered an email address to share concerns and feedback about the cut.
