Lets discuss the Opioid Crisis: What's Happening in Kansas?

On Tuesday, August 29th, [Kansas Health Institute](#) hosted a symposium on the opioid crisis on both the national level and in Kansas. Nearly 75 were in attendance from a variety of backgrounds such as law enforcement, insurance agencies, pharmacists, physicians, health advocates, state agencies, and treatment centers. Keynote speaker, [Dr. Andrew Kolodny](#), co-director of the Opioid Policy Research Collaborative at Brandies University, highlighted how drug overdose deaths have surpassed both motor vehicle and gun violence deaths in recent years and the level continues to trend upward.

This year at the OHK conference in November, will have a session, *The Challenge of Preventing Opioid Abuse* by Alan J. Murray, LCSW, LSCSW, Heart of America Professional Network, who will speak about how dental practices can

As Congress returns, work on CHIP resumes

Next Tuesday, September 5th, Congress will return to Washington D.C. from their August recess. As Congress returns to the Capitol, the deadline for CHIP, the Children's Health Insurance Program, is quickly approaching. Funding for the current program, which provides medical and dental insurance to nearly 9 million children, will end September 30th. If lawmakers do not extend the funding, states will exhaust their remaining federal funds for the program by the end of fiscal year 2018. In Kansas, this means the 79,319 children that are covered by this insurance program would be left without healthcare coverage.

- Funding not tied to other health programs, like Medicaid or the ACA

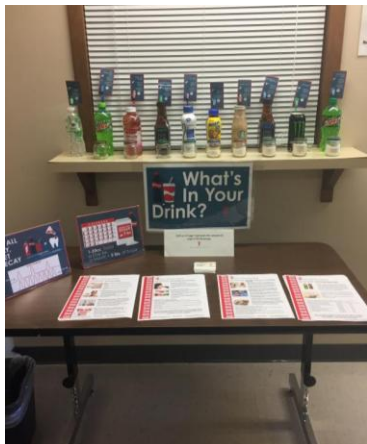
What can you do?


