KAMU Awarded Navigator Grant

Today the Centers for Medicare and Medicaid Services (CMS) announced that the Kansas Association for the Medically Underserved (KAMU) was awarded a Navigator grant for the third year in a row. KAMU has served as the lead agency and Navigator grantee since 2013 for the Cover Kansas Navigator Project. The project supports a statewide network of Navigators that conduct outreach, education, and assistance for Kansans, especially those uninsured or underinsured, to help them understand and access affordable health insurance options available through the Federally Facilitated Marketplace.

Navigators are trained specialists who provide consumers with in-person help, answering their questions about their health insurance and financial assistance options and assisting them as they

URGENT: Fluoridation Advocacy Opportunity

Ed Begley, Jr. is slated to be on the [opening panel](#) at the fall conference of the American Public Health Association (APHA). He is a television personality who is known for his environmentalism and for being an outspoken anti-fluoridationist. While he is on the agenda to talk about environmental issues, there is a danger in giving someone the podium who is a critic of the sound science behind community water fluoridation. He was one of the lead national spokespeople in the 2013 campaign to prevent Portland, OR, from being fluoridated.

The American Network of Oral Health Coalitions (ANOHC) is national sign-on letter asking the APHA to remove Mr. Begley from their conference agenda.
