KanCare News Stories

This week the Kansas Health Institute and Kansas Public Radio have presented a series of stories about KanCare. The <u>first part</u> aired on Monday and focused on the range of people who are served by the Kansas Medicaid program and affected by the transition to the private managed care program known as KanCare. <u>Part 2</u> was presented on Tuesday and discussed the cost of the program and the savings projected to be realized through the KanCare managed care approach. Care coordination is the cornerstone of the managed care model, and it is described in this segment. The third part aired today with a focus on other states' experience with Medicaid managed care. It includes discussions of studies about whether Medicaid managed care can improve services while lowering costs. The fourth and fifth parts will air on Thursday and Friday of this week. With the beginning of the new Legislative Session, new chairs of the health committees also took office. Representative David Crum will serve as the Chair of the House Health and Human Services Committee. He previously served as the Chair of that chamber's Social Services Budget Committee. In the Senate, Senator Mary Pilcher-Cook will serve as the Chair of the Public Health and Welfare Committee. She is a veteran member of that committee. These are the committees that will see any dental-related legislation during the next two years.

As the Legislature got started, the Governor delivered his State of the State address. In his address he called for additional income tax cuts, but did not mention the Medicaid program's transition to KanCare, which officially took place on January 1, 2013. Advocates will be waiting to see if the Governor will take a position on expanding Medicaid in 2014. The Affordable Care Act authorizes states to expand Medicaid to adults with incomes of up to 133% of the Federal Poverty Level. Currently only adults with incomes of approximately 33% of the Federal Poverty Level are eligible for Medicaid in Kansas. If the Medicaid program was expanded, the federal government would pay 90% of the cost for that population. The federal government pays about 60% of the cost of the current the Medicaid program. Expanding Medicaid would mean thousands more low-income adults would have access to the new adult preventive dental benefit.


