# Water Fluoridation Fails in Wichita

After a very hard-fought campaign to educate Wichita voters about the health benefits and cost effectiveness of water fluoridation, we learned early this morning that the ballot measure failed. Significant software and absentee ballot problems in Wichita led to a lengthy delay in the election results, including the result of the water fluoridation ballot measure. The final results were not available until nearly 2 a.m. Wednesday.

The result is disappointing, but the work of the proponents of water fluoridation remains impressive. Over 500 medical and dental professionals supported water fluoridation, as did over 50 local and state organizations. The Wichitans for Healthy Teeth coalition worked tirelessly for many months to educate elected officials and the public about water fluoridation. The unprecedented fluoride education campaign raised the profile of the issue and re-kindled a community conversation about the importance of providing effective preventive dental care for all Wichitans. The result of the election means nearly half a million Kansans will remain without access to fluoridated water and will continue to see tooth decay at a higher rate than Kansans who do have access to fluoridated water.

## KanCare Enrollment to Begin Soon

State officials confirmed on a conference call with providers and advocates today that KanCare enrollment packets will be mailed very soon. The enrollment packets will inform every Kansas Medicaid beneficiary of which managed care organization (MCO) they were assigned to. Beneficiaries will be able make a different MCO selection between now and the end of March 2013, and the entire Medicaid program is scheduled to switch to managed care, known as KanCare, on January 1, 2013.

To provide additional information about the transition of Medicaid to managed care, the state will host a KanCare member enrollment tour during the week of November 26-30 in twelve cities across the state. To view details of the locations and times, please visit the KanCare website.

## State Revenues Projected to Plummet

The State Consensus Revenue Estimating Group (CREG) met on Election Day for one of their twice-yearly reviews of the state revenue projections for the current and next fiscal years. The CREG estimates for the current fiscal year continue to project a positive ending balance, but the estimates for FY 2014, which begins July 1, 2013, are projected to fall by \$705 million. FY 2014 is the year when the full extent of the sweeping income tax cut go will be felt. The ending balance in FY 2013 next summer will cover part of the revenue loss in FY 2014, but nearly \$330 million in additional budget cuts and/or tax increases are expected to be needed to make up the remaining shortfall.

The significance of the current budget projections is that Governor Brownback will use these numbers when he builds his FY 2014 budget that he will present to the 2013 Legislature in January. It is far too early to know exactly how various parts of the state budget will be affected by the revenue decline, but we know that state agencies were asked to prepare for a 10% cut in their budgets for FY 2014. The Kansas Health Institute released a state budget puzzle earlier this year to help people better understand


the components of the state budget and how they work together. While the new CREG estimates are not included in the <u>budget puzzle</u> yet, it remains a useful tool in understanding the state budget.

### Kansas Legislative Races

In response to the 2010 U.S. Census count, the court drew new boundary maps in June of this year for all Kansas House of Representative and Senate districts. The new districts bore little resemblance to previous districts and resulted in several incumbent legislators running against each other and other districts containing no incumbent at all. Many races were decided during the Primary election in August, but all races were settled in yesterday's General election. The basic makeup of the House and Senate will remain roughly the same in 2013 as it was in 2011-12. The House will have about 92 Republicans and 33 Democrats, and the Senate will have 32 Republicans and 8 Democrats. But, the ideological makeup of the leadership of both chambers will change, as a majority of conservative Republicans have been elected in both chambers. In about a month newly-elected legislators will gather in Topeka to elect House and Senate leadership. The leadership election will determine not only the Senate President and Speaker of the House, but also will result in the assignment of all the House and Senate committees.

The makeup of the Legislature also will change somewhat as vesterday's election saw a few familiar faces defeated and a few high-profile races retaining incumbents. One of the most notable defeats is Rep. Brenda Landwehr, who serves as the House Health and Human Services Committee Chair. She lost to fellow incumbent Rep. Nile Dillmore, a Wichita Democrat. Ranking minority member of the Health and Human Services Committee Rep. Geraldine Flaharty also lost her race to fellow incumbent Wichita Rep. Phil Hermanson. The ranking minority member of the House Appropriations Committee, Rep. Bill Feuerborn of Garnett, also was defeated, but by political newcomer Kevin Jones. In three high profile races, Senate Public Health and Welfare Committee chair and ranking minority member Sen. Vicki Schmidt and Sen. Laura Kelly were re-elected, as was Senate minority leader Anthony Hensley. Full election results are available at the Secretary of State's website. Some election results remain very close, so the final results may vary a bit.
