**Board of Regents Task Force:  
Purchasing Dental Seats**

Three weeks ago we reported on a set of recommendations made by the Kansas Board of Regents' Oral Health Task Force. Kansas is one of fourteen states that does not have a dental school. Understanding the challenges our state faces by not having a dental school, the Board of Regents asked the task force to study oral health issues and make recommendations to the full Board of Regents. The task force recommended a two-phase approach to improving oral health in Kansas. The first phase was:

"Purchase seats from institutions in surrounding states (Missouri, Nebraska, and Oklahoma) and require that the students in those seats return to Kansas and begin working with underserved populations (e.g., Dental Care Service Deserts, persons with disabilities, Medicaid/HealthWave populations, persons without dental insurance, etc.). It is believed this action will help address the immediate issues of access to oral health care and fill the need for additional dentists in Kansas."

The state of Kansas currently has an agreement with the University of Missouri at Kansas City School of Dentistry that allows approximately 20 Kansas students each year to attend the school at the in-state tuition rate. The Board of Regents' task force recommendation regarding purchasing additional seats in dental schools would

Congratulations to Class 5 member Jon Stewart and the Heartland Community Health Center on producing a brilliant new video called "[Fill Up. Pour Out.](#)" The video shows the new approach Heartland is taking to health care and the role of generosity in the human experience.

Jon is the CEO of Heartland and

expand the possible number of Kansas dental students by allowing them to attend dental school in nearby states such as Nebraska and Oklahoma. The task force recommended:

"A baseline in-state tuition rate should be established in the student agreement, with the State of Kansas covering the difference in tuition. For example, in implementing tuition assistance with a variety of out-of-state schools, Kansas might consider financial support equivalent to that provided for Kansas students attending UMKC through the existing reciprocal program, and the state of Kansas would pay the difference between the relevant school's applicable tuition and \$32,238 (UMKC's current in-state tuition rate)." The task force also recommended the student contracts with the state of Kansas for the tuition assistance include an agreement that the student return to Kansas to serve in rural areas and/or serve vulnerable populations for a specified length of time.

In future Weekly Wednesday Updates, we will share additional details of the task force's recommendations.

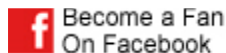
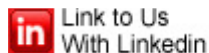
