# KanCare Comment Deadline This Week

The federal Centers for Medicare and Medicaid Services (CMS) is accepting comments through the end of this week on the KanCare proposal to move all Kansas Medicaid services to managed care. **Any comments need to be submitted by mid-day on Friday, September 21.**

Oral Health Kansas submitted comments on the state's first KanCare application earlier this year. As we have mentioned in previous Weekly Wednesday Updates, the original application was withdrawn and then re-submitted the federal government last month. We will submit final comments again this week that will be similar in nature to those first submitted. **To submit your own comments, please visit the [CMS comment page](#).**

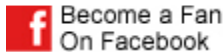
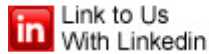
