KanCare Adult Dental Services Emphasized

Coverage for adult dental services was a topic of conversation at this week's meeting of the legislature's KanCare Oversight Committee. The committee heard testimony from more than two dozen advocates, including Oral Health Kansas, about KanCare, the state's Medicaid managed care program. In our testimony, we reviewed the comments we submitted to state officials last week jointly with the Kansas Association for the Medically Underserved and Kansas Dental Association. Our three organizations submitted comments about the state's plan for extending the current managed program known as KanCare 2.0. In the comments, we emphasized three things:

1. KanCare 2.0 should include the current value-added preventive dental benefit for adults.
2. A basic set of dental services needs to be covered for all adults, including diagnostic and periodontic services,
