Access to Dental Care in Rural Kansas

- **Dr. Melanie Simmer-Beck** is the Dental Public Health and Behavioral Science Department Chair and the Oral and Craniofacial Science Interim Department Chair at the UMKC School of Dentistry. She holds joint appointments in both departments. She has been teaching dental and dental hygiene students continuously since 2004. Her research focuses on access to oral health care, oral health workforce models and policy, implementation science, and program evaluation. She has been an Oral Health Kansas Board member since 2018 and serves serve as the Missouri State Champion for the "One Hundred Million Mouths Project."
- **Dr. Chuck Abbick** is the Executive Director of Dental Services at Salina Family Healthcare Center, a Federally Qualified Health Center (FQHC) in Salina, KS. His areas of interest include pediatric dentistry, oral surgery, educating dental students on rotations, increasing access to dental care for underserved populations in north-central Kansas, and inspiring members his dental team to reach their full potential. Dr. Abbick earned a B.S. in Mathematics from KU and a D.D.S. from UMKC, graduating from both universities Summa Cum Laude. His father, "Doc" Abbick, practiced dentistry in Junction City for nearly 40 years and is Chuck's inspiration for

- **Dr. Beatrice Brittan** is a general dentist in Abilene, KS. She earned her Doctorate of Dental Surgery from the University of Minnesota and practiced in Colorado before returning to her small hometown in Kansas to practice. Her clinical interests include prosthodontics, esthetic dentistry, and the integration of Botox and fillers in esthetic and therapeutic dental care. Integrating Dental Care in Kansas Medical Clinics

- A clinical dental hygienist for 33 years, **Kathy Hunt** began her work in public health in 2004 when she took advantage of a new expanded dental practice act to design the first system in Kansas that provided preventive dental care in schools, Head Starts, and health departments. She was also instrumental in developing, implementing, and directing a dental safety net clinic in her local community of Wamego. Hunt served as Project Director for Kansas Cavity Free Kids, a Kansas Head Start Association oral health project, for 8 years. She is co-author of several oral health resource materials focused on families with young children and works as a tireless advocate for the oral health needs of pregnant women and children birth to five. She has served as Oral Health Kansas' Dental program Director since 2015, leading the organization's educational programming.

Lived Experience Improves Dental Care for People with Disabilities
